






List of Victims of the mortar attack on the Nour residential complex located on kurdestan Shomali Highway, Tehran, on March 14, 2000

2 – Mr.Mohammad Mahdi Chizari, engineer, sitting in his car, was wounded on the left foot by mortar articles.









