





After shooting mortars on the city of Ilam on Jan.9,2000, and while escaping back to their bases in Iraq, the MKO terrorist agents passed through Chalsara village, (sheikh Mohammadi school) they came across with the youth of the village. The MKO agent fired at the students which resulted in the death of three people and injury of three more.

The incident: She was injured on head, face and hands in the military attack of MKO on the city of Kelar as a result of a tank bullet hitting their car.
























A picture of some arrested members of MKO, who were dispatched to Iran to execute terrorist operations, and were arrested before or after their operations.












# A photo of Houra Shalchi, arrested member of MKO addressing news agencies. April 12, 2001

After joining MKO, She was forced to divorce her husband and leave her child. Then she went to Iraq to get terrorist and military training. After her programmed instructions, and along with Marjan Malek, she was sent to Iran to carry out an artillery attack on residential parts of the capital, Tehran. She was arrested after her terrorist act, on her way back to Iraq.









In a part of her interview, she said that she had received:
"Technical military training under the supervision of
Iraqi officers in MKO bases in Iraq. All weapons and
ammunitions belonged to Iraq."

He was recruited to MKO in Verginia, USA. After preparatory training he came to Iraq to complete his terrorist and military training. He was dispatched to Iran, accompanied by Mehdi Baimani to assassinate Mr. Seyfollahi. During the operation, he lost one of his hands as a result of a grenade explosion. He was subsequently arrested.

(Mehdi Baimani was killed in armed clashes while crossing the Iran – Iraq border)
