

Help MEK Child Soldiers Rebuild their Lives

July 29, 2024

Children in the military, including state armed forces, non-state armed groups, and other military organizations, may be trained for combat, assigned to support roles, such as cooks, porters/couriers, or messengers, or used for tactical advantage such as for human shields, or for political advantage in propaganda and even sexual abuse. There is huge evidence that the Mujahedin Khalq (MEK/ PMOI), as a para-military organization has used child soldiers.

However, these are a few of hundreds of children who were separated from their parents, smuggled to the West and then again smuggled to Iraqi to attend the MEK's military force. There are still a large number of young girls and boys who are in their thirties and forties, taken as hostages inside the MEK's camp in Albania, isolated from the outside world. The reintegration of these young people into civilian life is an essential part of the work to help child soldiers rebuild their lives.

Mohammad Beit Salem, a 7-year-old victim of the MEK

July 27, 2024

Mohammad Beit Salem was only 7 years old when he was injured in a mortar attack by the terrorists of the Mujahedin-e Khalq (MEK/ PMOI/ Cult of Rajavi).

Mohammad is from an Arab family living in Ahvaz, Khuzestan, Iran. He and his family were all on a motorbike when they were attacked by the MEK agents on November 29th, 1999 in front of the faculty of literature of Ahvaz university, near the Fifth Bridge. The attack left the parents

and their two young sons disabled for life.

When in 2009 the European Union delisted the MEK from its list of terrorist organizations, Mohammad's father, Abdunabi Beit Salem, a worker, wrote a [protest letter](#) to the Union and ironically asked the authorities to put him and his family on the terror list "so that the system will be completed"

Amir Yaghmai, former child soldier of the Mujahedin-e Khalq (MEK) explains some points about "Children of Camp Ashraf".

Children of Camp Ashraf is a documentary directed by the Iranian journalist and film maker Sara Moien. The film is based on the life story of four of near a thousand children of MEK members who were separated from their parents in 1991 and were smuggled to Europe and North America.

The children were left in foster families who were MEK sympathizers, in most cases not with normal qualifications of a safe family. Amir Yaghmai, Parvin Hosseinnia, Atefeh Sebdani and Hanif Bali are the four Swedish citizens whose traumatic childhood involved with the MEK cult is narrated in the documentary.

Amir usually gives updates about the process of broadcasting the film on his accounts on social networks.

Reflections on Nejat Society's gathering in Albanian media

On June 23, 2024, Nejat Society Albania, held a gathering in Tirana. The gathering was welcome by the Albanian public and media.

As an officially registered Albanian entity, founded by former members of the MEK and Albanian citizens, Nejat Society Albania received a large number of Albanians and Iranians living in Albania, in Tufinë district of Tirana. The event was covered by correspondents from various Albanian media outlets.

The news coverage of the gathering was done by several Albanian TV and radio channels and news outlets. They considered the gathering as a conference on human rights of members of the MEK who are confined and tortured in the group's camp in Manez, in North of Tirana. They reported on testimonies of defectors of the MEK who are current members of Nejat Society Albania and on the speakers of the event who de-

fended the rights of MEK members and their families in Iran.

The conference was regarded as humanitarian event which was focused on the rights of Iranians who are taken as hostages in Manez and their families who are not allowed to travel to Albania to visit their loved ones. It was also perceived as a cultural opportunity for mutual relationships between Iranians and Albanians.

Val-d'Oise: search of the premises of the Mujahedin-e Khalq (MEK)

According to our information, the premises of the Iranian organization of the People's Mojahedin were the subject of a police intervention this Wednesday afternoon.

The premises notably house a television, relay of the organization.

An intervention seemed to indicate that around fifteen people lived there. Border police found three people who are prohibited from being on French territory.

A major control operation took place this Wednesday within the Sima association, whose premises are located in the Vert Galant activity zone in Saint-Ouen-l'Aumône.

The Urssaf therefore wanted to check, this Wednesday, whether these premises did not house hidden work.

Finally, the border police (PAF) came to control the administrative situation of foreign people there, with the assistance of the Cergy police station.

Swedish SVT broadcasts “Children of Camp Ashraf” on the anniversary of Maryam Rajavi’s arrest

The documentary film “Children of Camp Ashraf” will be broadcast on Swedish TV channel SVT. Amir Yaghmai, a former child soldier of the Mujahedin-e Khalq (MEK), announced this news on X social network. The documentary will be shown in Swedish with English subtitles on Monday, June 17, at 10 pm local time. “Barnen Fran Camp Ashraf” is the Swedish title of the film.

The documentary Children of Camp Ashraf directed by Sara Moin is about the lives of four Swedish citizens who were the children of the MEK. Under the order of Masoud Rajavi, they were smuggled to Sweden where they were handed over to the families of the MEK sympathizers, and suffered serious traumas.

Le Monde’s four-page report on child soldiers of the MEK

Ghazal Golshiri, journalist of Le Monde, in a detailed report published on four full pages of the newspaper along with a number of photos recounts the fate of three former members of the People’s Mojahedin organization (PMOI/ MKO/ MEK) who had joined it since childhood and adolescence. The main title of the report is: “We, the child-soldiers of the Iranian Mujahedin-e Khalq”.

The three people mentioned in the Le Monde report were born in the 1980s and had parents who were close to the MEK. Along with photos of these three people, Le Monde mentions their real names as follows: Amir Vafa, Mohammad Reza Torabi and Amin Golmaryami.

Amin Golmaryami says: “We were left in the hands of an organization that betrayed us and led us to war... Many of our friends have died. Some self-immolated. But the Mojahedin organization is still unable to accept its faults and apologize. Those who claim to fight for the freedom of Iranians must first start by freeing their members.”

Why is le Monde's investigative report on the MEK child soldiers worth to read?

June 11, 2024



The French newspaper Le Monde published a detailed report about former child soldiers of the Mujahedin-e Khalq (MEK). This report, written by Ghazal Golshiri, has four full pages of this widely circulated newspaper. It is titled: "We, the child-soldiers of the Iranian Mujahedin-e Khalq". The publication of the report is important based on different aspects.

After the publication of the life story of Amin Gol Maryami, a former child soldier of the MEK, in Germany's De Zeit magazine at the end of 2021 and the screening of the documentary "Children of Camp Ashraf" in Sweden at the beginning of this year, four full pages of the national newspaper of France were dedicated to this topic. It can be a big step in the advancement of the army of former child soldiers against the leaders of the MEK.

.....

The army of child soldiers who are open to speech reaches tens of people, according to Golshiri. The audience of the free media has become familiar with the names a few of them. Considering that the number of the trafficked children of the MEK was over a thousand, this army has the capacity to mount to several hundred people. About 500 of these children are still under the control of the organization and their names are used when writing letters against the former child soldiers who criticize the group.
