"Over 40 former members of the group and a number of people who were injured filed a lawsuit in this case," Zabihollah Khodaian told the reporters in a press conference.

"The court, through the Foreign Ministry, notified the Ministry of Justice of the countries in which the group operates," he said adding, "as you saw, the group leader reacted to this case in a message."

Khodaian added that the court ruled that the MEK's leader must deliver the sum of 7,660,000,000,000 tomans in compensation to the victims who have suffered physical and mental damage.

The first court hearing in the crimes of MEK leadership was held in March 2021, when 42 former members and victims stated part of the physical and mental tortures of the MEK.

Abdulrahim Nazari was deceived by the Mujahedin Khalq (MEK) recruiters in Turkey and taken to Camp Ashraf, Iraq while he had no idea about the group.

Abdulrahim was a young Iranian Turkman that traveled to Turkey to find a job in 2002. He was married but he left his wife and children in Iran in order to make money in Turkey. "I was looking for a job in Ankara," he recounts. "I was running out of money when I ran into an Iranian man there. He claimed that he had a god job offer for me." The man was called Ali Ankarai who was the MEK's recruiter in Turkey. Most of MEK defectors name him as the person who deceived them to go to Iraq and join the MEK. He took Abdulrahim to a hotel and paid all his expenses for a few days.

"He insisted that I not leave the hotel," Abdulrahim says. "After a few days, Ali Ankarai came to the hotel and told us about an excellent job with an excellent payment in Germany. He said that we had to stay in a three-months quarantine in Iraq and then we would be transferred to Europe. Then he began playing some films of Massoud and Maryam Rajavi for several days. I did not know who the MEK was." The brainwashing process had been started.

Together with six other people, Abdulrahim was taken to Camp Ashraf, Iraq. He recounts the day they entered Camp Ashraf, "When we arrived in Camp Ashraf, a number of female commanders of the MEK received us. To our surprise, they gave us some military uniforms! We asked, 'why'. We were answered 'you are a member of Mujahedin Khalq now'. We protested and asked to leave the group but exit was forbidden. They said 'You know Camp Ashraf

now. We cannot let you go. If you really want to go, we will submit you to Iraqi police and they will jail you as spies and eventually you will be sentenced to at least eight years of imprisonment." " This was the beginning of the three-year for Abstay dulrahim Nazari in Camp Ashraf. "I cried all day long the first day I entered Camp Ashraf," he says. "After a few days commanders started the brainwashing sessions. They held so many sessions that we were left no time to think."

After the American invasion to Iraq in 2003, the MEK was disarmed by the US military and Camp Ashraf was guarded by them. The US army commanders set up a camp called TIPF in order to settle those who want to leave the MFK Abdorahim Nazari could manage to leave Camp Ashraf and join TIPF. He ultimately returned to Iran and got back to his family in his home town, in 2006.

His wife who had suffered a lot in the absence of Abdurahim soon died after her husband came home. "This is the fault of the traitor leaders of the MEK that I lost my first wife," he says. "She could not survive those huge sufferings. She has a heart stroke and passed away. I do not forgive leaders of the MEK."

Abdulrahim was depressed after his wife's death. It took him some time to encourage himself to keep on. He got married again. About his new life he says, "Thank God. I have a happy life now and I try to keep up our happiness. I am hopeful about my future. I am very grateful to God because he helped me leave the MEK." As a defector of the MEK, Abdulrahim Nazari supports the action taken by 42 defectors of the group to complain against Massoud and Maryam Rajavi and other high-ranking members of the MEK in the International Court of The Hague.

Tahereh Nouri was only twenty years old and the mother of a nine-months old baby when she was taken as a hostage by the Mujahedin Khalq Organization (MKO/ MEK/ PMOI/ Cult of Rajavi).



"As a young girl, I had married a greedy man who ruined my life," Tahereh writes in the memoirs she has published on her experience of involvement with the MEK. "My husband was jailed in Arak, Iran, where he got to know a man named Mehdi."

Mehdi was actually an MEK recruiter who succeeded to deceive Tahereh and her husband to join the MEK. "He promised to take us to Iraq to work in the MEK camps with good payments for two months and he claimed that eventually we would be sent to Europe to build a new life."

As Mehdi asks them, Tahereh and her husband take their passports and travel to Turkey where they are welcome by MEK agents. "We were settled in a safe house of the MEK for about a week," she recalls. "They showed us films of the life of families in Camp Ashraf."

The group agents take them to Iraq. They are housed in base of the MEK in Baghdad called Tabatabayee. "We were received warmly with good food and residence," Tahereh says. "Again, we were shown videos of Massoud and Maryam Rajavi's speeches. After several hour, they put a document before me and told me to sign it. They told me to divorce my husband in order to comply with the rule of Massoud Rajavi."

I really thank you from the bottom of my heart and I sincerely say that during these years, these people really worked hard for us in various fields and made it possible for us to make our voices heard by our loved ones in any way possible.

I am Behrouz Oladi. In 2004, my sister Masoumeh Oladi was abducted by Rajavi cult agents on her way to school while she was a 16-year-old girl. At noon that day, bethat time, let alone my 16-year-old sister.

cause Masoumeh did not return home, we quickly went to many places looking for her. We informed many organizations and bodies. In the evening of that day, at 11 pm, we were informed that Masoumeh had been abducted by individuals and was now a prisoner of the Rajavi Cult in the Ashraf garrison in Iraq. I, who was about 20 years older than my sister, had never heard of the MEK at

The organization declares that people are there of their own free will! I ask you if it is possible for a 16-year-old girl who has not heard the name of this organization at all and does not know what the organization wants, go to another country and join this cult willingly?

Over 10 times I went myself and about 5 times with my old and ill mother to visit my sister at the door of Camp Ashraf in Iraq. But every time

I was confronted with obscenities, insults, and repeated attacks with stones, bows, and arrows on myself and my mother. I was injured many times. Even on a trip I had with my mother, the pressure on my mother and myself was so intense that a doctor who had been stationed by Iraqi forces when he examined mother said that my mother's blood pressure had reached 19 and was very high. I rushed my mother to a hospital in Baghdad.

Now I ask you, all human rights and international organizations, how an organization that supposedly inspires human rights and democracy does not allow an ailing, aged mother and a brother who were thousands of kilometers away from their own country and had come empty handed to the door of Ashraf garrison to visit their loved ones, even from a distance of 10 meters. I was severely trau-

matized in two ways. First while being away from my sister, my teenage sister who has been abducted and I have not seen her or heard her voice for 20 years. Second, my old and miserable mother, who is constantly grieving my sister.

I'm talking to you now from my mother's house. But she can't sit next to me even for 5 minutes. I lost my father. My mother is also waiting for my sister. Every moment there is a conversation, she asks me with tears in his eyes that what about Masoumeh?

All the loved ones and families who were with us at various ceremonies and were with us at the entrance of Ashraf garrison know me and my mother. Our subject is families. It is a matter of humanity. It is a matter of emotion. All the loved ones who have suffered physical and mental damages in this organization, and are now separated, have complained

against the leaders of the organization and the families are also complaining. I express my full support for this complaint.As a brother, on behalf of all the brothers, sisters, fathers and mothers who are really waiting for 20 years, 30 years, 40 years, more or less to see their loved ones, I wish that they can see the beautiful faces of their loved ones. God willing, good news will come to them day by day. Hear the news of every MEK hostage's seperation and release makes us delighted.

There were family members of MEK hostages among us who have passed away. There are also families who are sick and disable now.

I wish that all the loved ones who are in the captivity of this cult be released and return to their families as soon as possible. I wish good health for all the families, especially the hardworking loved ones in the Nejat Society.

Following the recent complaint against the MEK leaders filed by 42 defectors of the group, the Nargesis declared their support for the plaintiffs of the case. "As a member of the Nargesi family, I complain against the leaders of the Cult of Rajavi because they kidnapped and imprisoned my sister," Sara Nargesi told Nejat society. "My family and I declare our support for the plaintiffs and we declare our readiness to make an official complaint against the leaders of the group in any fair court."

Hadi Naseri Moghadam was in the Mujahedin Khalq for 15 years. He joined the group not as a political activist but as a young Iranian who wanted to immigrate to Europe.



Hadi was born in 1973, in Gorgan, Iran. When he was 27 years old, a human trafficker promised to smuggle him to Europe. Hadi wanted to travel to Turkey in order to open his way to move to Europe but the human trafficker convinced him to go to Iraq and to stay in the MEK's military base in Iraq, Camp Ashraf. Hadi recounts, "I told him, 'I do not feel like serving in a military base', but he promised me that my stay in Camp Ashraf would be only six months".

However, his stay in the MEK lasted 15 years, from 2000 to 2015. He illegally entered Iraqi territory through Kurdistan border. "When I arrived in the entrance unit of Camp Ashraf, I was received by a woman named Laya Khiabani who interviewed me," Hadi describes his recruitment process in the MEK. "She asked me what motivated me to struggle. I had no answer. I had no political motivation. I told her that I had gone there to stay for six months and then I would go to Europe as the human trafficker had told me but Laya told me, 'He is not a human trafficker. He is our agent to recruit people in Gorgan."".

Laya intimidated Hadi by reminding him that he had illegally entered Iraq. She told Hadi that he would be imprisoned by the Iraqi security forces in Abu Ghuraib prison if he wanted to leave the group. She also threatened him that he would be punished as a spy by the Iranian security forces if he tried to cross the border to get back to Iran. "I had no way to move backward or forward," Hadi said. "I was stuck in a system that I could imagine no future for myself."

Dear friends, in this video, an elderly Iranian mother next to her husband appeals to the Albanian authorities to grant her and her husband visas to come to Albania to meet their son **Hassan Heirani**. They have not met their son for 28 years, and even for 14 years they could not even talk to him, because the Rajavi Cult (Iranians in Manzeh) do not allow members of the Cult to contact family members.

The mother is ready to meet her son in Albania even in the presence of the Albanian authorities, so not only for herself, because she fears the slanderous campaign of the Rajavi Cult with "gogols" of the Iranian spy type, terrorists of the Tehran Regime, mercenaries of the mullahs of idiocy of this kind.

I believe that the Albanian authorities will grant Albanian visas to two elderly Iranian parents, otherwise I publicly promise that I will do not only what is possible, but also the impossible to stigmatize the wickedness and lack of human feelings among the high hierarchs of "Renaissance" of Prime Minister Rama.

I believe that it is worthwhile to provide this elderly couple with a visa, so that the renaissance does not pay the bill of a negative publicity inside and outside Albania.
